
Lot 544, Section G, Twin Lakes Subdivision, an Addition to the City of Little Rock,

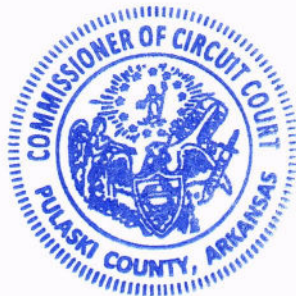
